Italy stated, in its response to the draft status report, that "Assessment of completeness" is provided in the NIR not as an annex but as a paragraph (para 1.8), and information on "Tables 6.1 and 6.2 of the IPCC good practice guidance", is included in the NIR applying the tier 1 uncertainty analysis in the relevant tables (Table 6.1 of the GPG) provided in Annex 1 of the NIR for the year 2007 excluding and including the LULUCF sector (see Table A1.3 and A1.6 of the NIR).
